## Health & Safety Policy 2024

**Little Cubby Spaces Limited (Little Cubby Spaces)** acknowledges and accepts responsibilities under the Health & Safety in Employment Act in 1992 and Health & Safety at Work 2015 and will take all practical steps to protect employees, customers and others affected by the company's business including the hazards associated with the working practises, procedures and use of hire equipment.

To achieve this, we will put in place Health & Safety Controls such as:

- Provide a safe place to work, safe materials and safe equipment with appropriate training and knowledge to work.
- Ensure our playhouse designs comply with NZ Standard NZS5828:2015
- Encourage active participation from all members of the team with regards to the safety of the workplace and assessing risks and hazards during the working day.
- Implement a best practise to identify and control hazards in the workplace to prevent injury.
- Report, record and investigate accidents, injuries, illnesses and incidents.
- Support employees return to work after sick leave due to illness or injuries.
- Ensure emergency plans are in place for different locations of set up and head office.
  Contact event organisers and receive copy of emergency plan for team in advance of offsite location.
- Provide open communication in the work space to look at improvements to Health & safety working practise.
- Have a commitment to Health & Safety procedures and policies for the organisation's stakeholders.
- All employees are required to comply with the company's Health & Safety policies and procedures along with the Health & Safety Act.
- The Health & Safety policies and procedures will be assessed on a quarterly basis throughout the year to look at areas of improvements required, monitor performance and assess new controls to implement.
